CITY OF AZUSA BOARD AND COMMISSIONS

The City Council has established the local advisory board and commissions by ordinance. These advisory bodies are responsible for making recommendations on a variety of topics to the City Council for consideration and final determination.

The City Council recognizes that there is a vast and largely untapped reservoir of talent that exists among the Citizenry and encourages citizen participation on these advisory bodies.

The City of Azusa has six standing commissions and one board: Architectural Barriers Commission, Cultural and Historic Preservation Commission, Human Relations Commission, Library Commission, Parks and Recreation Commission, Planning Commission and Personnel Board, who are appointed or elected. ARCHITECTURAL BARRIERS COMMISSION:

This Commission has been temporarily suspended in order to examine the role, purpose and mission and decide how it can best serve the Council and the Community. Appointments to this Commission will be refrained and all future meetings will be suspended until the review is complete.

The Architectural Barriers Commission acts in an advisory role to the City Council on all matters pertaining to areas that lack handicap access, makes recommendations concerning additions or amendments to state and federal laws, and city ordinances concerning handicap, recommends programs, training sessions or other similar events to provide information to the public on matters relating to handicap access. ([*Azusa Municipal Code Chapter 2, Article V, Division 2*](#))

The Architectural Barriers Commission is a 4 year term appointment, meets on the 3rd Tuesday of the month at 4:00 P.M., in the Light & Water Conference Room 1st floor, 729 N. Azusa Ave.; Liaison - Christina Curiel, (626) 812-5247.
